## Meeting called to order at 6:35 pm by Janice B.

### Principal's Report - Adam M.

- Enrolment update: 2,055 students as of last week; this puts Northern and Earl Haig both as the largest schools in the TDSB. Various solutions for finding extra space were shared boundary changes, portables and renting nearby external space were not suitable; three rooms in the school will be refreshed for next year (rooms 312, 318, 143).
- Staffing update: many interviews for vacant teaching positions have been completed. Shortage of science teachers across the board.
- Facilities update: ventilation issues in the library and upper gym are being addressed (get uncomfortably warm). Undertaking two 4-year projects:
  - Courtyard revitalization project: Northern has a south, shaded courtyard and a north fairly functional courtyard.
  - Heritage room: two large windows might be cut into doors to lead into the courtyard.
- Questions:
  - o Is there a lot of peeling paint in the building? Yes, there is.
  - Bathroom functionality? An ongoing challenge with standard problems such as damage by students, and vaping. 90% of issues are in the boys' washrooms.
  - Have Grade 9 Chrome books arrived? To be confirmed

#### Other business

Co-Chair John B. highlighted the TDSB's Fundraising Policy P021 which is currently being reviewed by the TDSB, and invited parents to give their input, as the proposed changes would alter the way that fundraising proceeds are allocated.

Specifically, the following policy is being proposed:

6.2.1. To facilitate improved equity of resources among schools with different socioeconomic status, a System Priorities Fund will be maintained to redirect designated/undesignated donations from external sources and/or voluntarily directed surplus funds generated by school communities. 6.2.2. A process for the allocation of System Priorities Funds will be determined by the accompanying Fundraising Procedure (PR508).
